- Condition of the State Address, Andy Ney attended in the Gallery. She recognized that the House was working on an EMS as an Essential Service –and she said she would be working with the House on that.
- Kaufmann is moving this to a different committee to get it moving forward. If things go well we're going to try to get it done quickly as
  possible.
- Our challenge is getting into the budget on the Tax Reform bill. We'll need to really be effective with our emails to legislators. Call to Action items are really important and time sensitive.
- Weekly report will go to Legislative Committee starting next week.
- A few bills are already
- Sirens and lights, vehicle registration minor issues that other public safety are working hard on. Our priority is essential service.
- Majority Leader in the Senate is Jack Repper, President of the Senate is Jake Chapman.

#### Bureau of Emergency & Trauma Services Report - IDPH Rebecca Curtiss, Bureau Chief BETS

- A few snafu's on background checks –nothing broadly concerning –working through them
- Pilot Projects U of I Quality Improvement/Quality Assurance Program
- COVID still working with Test Iowa Sites and infectious diseases and the team leader on the Vaccine
  project in the state. EMS Providers are in Phase 1A through Public Health Agencies to be sure you all are
  getting your vaccines.
- Advisory Council sent out updated info on Phase 1A
- Hoping to move to Phase 1B soon depending on availability of the vaccine. Iowa is in the top 10 States
  for doses in the administered and received. There will probably be some changes on how it's delivered and
  administered.
- Judicial Funding that came through last year. We were promised about 1 Million. But it started very slow. It
  did pick up a little end of summer into fall have almost \$100,000 in that account now. Making decisions on
  how that will be allocated. But it doesn't go far—trying to make as big an impact as possible. Continuing to
  look for ways to do that.
- Governor's Mention was amazing, very excited about that.

## Medical Director Report - Dr. Christopher Hill -

- Dr. Hill received his vaccine. Second Day is no joke minor side effects. Possibly not able to work. Think of
  that in terms of scheduling. Make sure it is not the entire department—staggering is best.
- Protocols NE Iowa Group 6 medical directors are working to update. Additional ID medications. Full
  Authorization Level might have changed -a lot of questions about that.
- EMSAC think innovatively and bring some new pilot ideas.
- Great showing of data coming out of the reporting from IDPH. It's very helpful to use to improve.
