

# July 20, 2017 – 1-3pm -- Board of Directors Meeting Teleconference

Call To Order by Mark McCulloch, President at 1:05pm

<u>Welcome/Roll Call/Proxies/Determination of Quorum/Conflict of Interest</u>—Lisa Arndt, Office Manager took Roll Call. Roll Call is at the end of this document. Quorum is established.

<u>Approval of Agenda</u> BETS staff are not in attendance today. There is a motion to amend the agenda to replace the BETS Report with a report from Mission Lifeline's, Gary Myers—as is indicated in the new business on your agenda--Brian Rechkemmer 1<sup>st</sup>; 2<sup>nd</sup> Mary Briones—Motion approved. Motion Carries.

AHA Mission Lifeline – Gary Myers and Katie Bergan – need to get the word out that Mission Lifeline education is FREE, available, and in comparison to other states, underutilized. Mission Lifeline is dedicated to Iowa through the AHA quality system improvement projects for mission lifeline. Iowa's contact to use these grant dollars ends which is January 2018. Not much time left to take advantage of these grant monies. EMS Education as part of the Mission Lifeline Grant. He wants promote Cardiac System of Care Education across Iowa. There have been 52 sessions so far across Iowa. The training is available for FREE for all Iowa EMS providers. They have a system of Train-the-Trainers—they have trained them and they're ready to go out to the agencies to do their training. We are not having the response we expect. As a comparison—MN and NE each did about 100 agency training sessions (not including ones done my Mission Lifeline Staff). We only have 52 so far in Iowa—and there are a lot more agencies in Iowa than in Nebraska and Minnesota. We anticipated a large call for this training and have not gotten it. As a comparison—the monies that are left for training from Mission Lifeline in Nebraska, the call was so big, they still have those monies to work with to get training done, post contract ending, because there is such a high demand. We'd like to see that happen in Iowa as well. We've done lots of marketing in Iowa—easy to sign-up—but that might be the problem with that. It's important to note this education is broader than just how to apply EKG Leads. Perhaps that is where the lack of request for training is. Asking that our board members—help with looking at how we're getting the word out. The trainers are getting paid to train by the grant—not by the agencies. To sign up--go to the Mercy of Health Sciences website to sign up—it's right there.

#### **Discussion:**

<u>Mark McCulloch, President</u> – we hear all the time that training in general is not easily accessible (referring to location of the training) and that cost is an issue —and yet this is available at their location and it's FREE—and they are still not taking advantage of this training opportunity.

<u>Brian Rechkemmer</u> – can we have a sign-up document and outline of what the training consist of that we can push out to our services? There might be a misunderstanding about what this training is all about. Gary Myers will take a look at the documentation—address this issue and send it along to Mark McCulloch. We will then get it out to our directors to distribute and to the office manager to distribute via our website and E-news. Gary Myers will also send the information Chief Rebecca Curtiss at BETS, she has indicated she will get the word out through her list serve. Mission Lifeline wants to meet people where they are, so all they need to do is sign up for a training slot. Also--they are willing to a session at a conference—if you have a slot at a local conference—contact Gary Myers to arrange to have a trainer at your event.



#### **Approval of Minutes**

 Motion to Approve the --June 22, 2017 Board of Directors Meeting Minutes—Linda Frederiksen 1<sup>st</sup>; Ladonna Crilly 2<sup>nd</sup>. Motion Approved. Motion Carries.

Lobbyist Report -- Michael Triplett reported. There was a meeting yesterday with consultants from out of state on the GEMT Program—Jerry Ewers, Linda Frederiksen, Jeff Dumermuth, Mark McCulloch and Mike Triplett attended. Mike Triplett had to leave early. The consultants recommended we try to get a bill introduced and passed. But the department can do it by itself if not passed. Mr. Triplett indicated we should make it a higher priority this year. It's a federal program that is administered by the state and since the state is not paying us as much-through Medicaid reimbursements—this would help increase that amount nicely without affecting the State budget—as it comes from a federally funded program. With this GEMT Program – we might be able to draw down a lot of money from the federal money. Policy wise—the consultants and GEMT representatives are excited about doing it as well. Mark McCulloch reported, not a lot of group discussion from involved parties after the meeting. It was more informational meeting about the GEMT Program. Mr. McCulloch's understanding is it would supplement the low rate of reimbursement of Medicare in the state of Iowa. Mark's been in touch with someone that is an expert on GEMT—he will attend our legislative strategy meeting—not set yet—but will be in the next few weeks. It's a win for the state—it doesn't cost the state anything—and will help many EMS providers in our state. State of Iowa Medicaid representative there—they were very excited about it. Linda Frederiksen reported that they gave some examples of some services and how it would help them. It's an entitlement program—money that EMS Services have not been aware of previously. But you have to generate a SPA at that is 60,000 hours—which is a lot of work. But it's been very successful—with hundreds of thousands of dollars. If it can go through the rewards would be plentiful and the reimbursements Iowa Medicaid makes a request to Human Services to include monies from GEMT. It's an entitlement and payable, but the State has to decide they want to do it. It's a huge benefit to the State and local tax payers. The state would get an administrative budget—to administer this program. Linda Frederiksen indicated, based on what was presented at yesterday's meeting -- If we get started now—money wouldn't be seen until 2019 or 2020. She also mentioned, it could be seen as Medicaid expansion and that could be a sticky point. Three of the larger transporting services— Medic EMS, Care Ambulance and Siouxland Paramedics—are all non-governmental, but have contracts to provide 911 with their counties—every area is different—but even those can be worked out to get them involved. We just need to get moving on this.

<u>Treasurer's Report</u> –Brandon Smith by written report – Motion to approve of this financial report by Brian Rechkemmer; 2<sup>nd</sup> by Mark Sachen – Motion Carries.

## June Financials 2017 - written report provided by Brandon Smith-

- June 2017 Financial report as written by Brandon Smith, Treasurer.
- June P&L INCOME: Gross Profit \$10,201.95 most of that being revenue from Conference (Exhibitors, Sponsorship) and Membership collections.
- EXPENSES: Total Administrative \$13,696.25, with Billing and Management Conference expenses and Lobbyist fees making up the majority.
- Month of June net loss of -\$7,068.96



- Looking over the P&L vs. Budget Performance and YTD, Administrative Expenses are at \$67,043.43 which is slightly under the YTB Budgeted Administrative Expenses \$69,669.86.
- Also looking back at last year's P&L YTD for this same time we have a 3.1% (\$1,652.53) increase in Revenue and a 2.1% (\$1,402.97) increase in Administrative Expenses YTD.
- The Balance Sheet Shows total Assets and Liabilities of \$399,602.10 The
  checking/savings(money market) account balance of \$378,873.26 and A/R of \$11,119.50, of
  which \$5,117,50 has recently been invoiced to Klocke Emergency Vehicles and LifeLine
  Emergency Vehicles. Lisa updated that these invoices were paid this week.
- Money Market account balance is \$300,161.04. Interest accrued, \$66.60.
- I have not received the Regular Checking Account statement at the time of this writing. Lisa Arndt distributed the Checking Account Statement to all directors.
- Lisa Arndt Reported—as requested by Brandon Smith, Treasure on A/R Summary two exhibitors are paid—the other \$6,000—consist of a few invoices we opted to leave on the books—they have to pay if they want to return. There are a few-2015 invoices that I am working with Vendors—still to collect—they will not be able to get a booth again until they pay up. And one invoice to Unity Point for the Leadership Sponsorship Invoice—Katy Hill and I are working on it. And finally a few hundred dollars in "Extra Exhibitor Badge Invoices" from 2015 I am trying to collect as they register this year for a booth.
- Hopeful, changing the accounts to Money Market and the checking account to eliminate fees
  and reducing credit card processing fees. Hopeful it will help us. Waiting for the end of year to
  see how it comes out.

<u>ISICSB Board Report</u> – L. Frederiksen reported– Chris Myers went through a strategic planning process in June. Board is continuing with the Motorola state-wide build out.

<u>Office Administration</u> – L. Arndt—Apr/Jun VOICE is out—holiday delayed it's printing and delivery – Brian Rechkemmer got his at the college and at home. No registrations in yet. We are hoping they are pulling them out and submitting them for approval now. We should have a better feel in about a month. This is the earliest the online and print registration has been out. The full session descriptions are not in this issue—they will be in the Jul/August issue that will go out to the entire state of Iowa EMS Provider List by the end of August.

**Scholarships** – B. Rechkemmer – Scholarships--all 17 of them are in and original applications PDF has been sent to committee members to review and access. The—spreadsheet with the candidates' names and application basic information is also out to committee—this spreadsheet includes history of application from 2014, 2015, 2016 as well as the current 2017 applications. The first weekend in August the committee will get together to discuss and finalize the awards—and will announce those awards at the August BOD meeting on these scholarship awards.

**2017 Group Purchasing Agreement** – L. Arndt – Three bids in. Nella Sievert will be compling the data comparison sheet for the 3 bids and will be getting a meeting together to make a decision. Current contract ends in two weeks—July 31, 2017.

**Community Paramedicine/MHC** – L. Frederiksen – this committee is now a sub-committee of EMSAC.

**NAEMT** – Mark McCulloch – Jeff Dumermuth resigned as NAEMT advocate. Mark McCulloch called Dave at NAEMT to discuss our options and what to do moving forward. Gave him our history. He will be sending a job description and Mark will be assigning a representative.

- <u>Red Flash Group</u>—Greg is no longer there. Jeff Berens called to apologize. Status of proposal to
  use monies for this item to secure accounting pieces that came in over budget. We have
  decided to reallocate these monies to securing and getting an outside accounting firm up and
  running.

## **New Business**

- <u>GEMT –</u> see legislative report above this will be one of our main efforts this year. To get together with the partners to put together a steering committee. We know it's going to happen, but it's going to take some time.
- Request to support filling the IFSTB Bureau Chiefs Position Thomas Creighton is the one requesting—that's good. We will contact them—to throw our support their way.
- <u>DMAT Advisory Group</u> Rod Robinson—has retired—Jason Wickizer has agreed to represent IEMSA on this group.
- e 2013 and 2014 CDRT Annual Reports we received the two years of child death review reports. Very telling, outline causes of death, age, and show the trends. They are in the infant stage—mostly because of birth defects. Other than that—it's Trauma that is the highest cause of death. These were sent from Gerd W. Clabaugh, MPA Director of the Iowa Department of Public Health. Mostly these reports are done working through Medical Examiners. But this information can really help EMS Service Directors to focus their training dollars and focus our efforts on the area that statistically has the biggest impact on their providers and management team. This is not distributed to EMS—but we think it's VERY helpful to EMS. Mark McCulloch will investigate approval to share with EMS Services.
