- -GEMT Update We're getting closer. Our hard work on this important program is getting closer to finalized. Renewed another 6-month contract with Karla McHenry same terms as the last extension.

Just a little background and summary from our consultant -

There are **two** parts that must be approved by CMS for implementation:

- 1. The State Plan amendment (approved last Friday) and,
- 2. the 42 CFR 438.6(c) pre-print for managed care (not approved yet.)

Also, the decision (see details below) on the dry runs, essentially means there will be no supplemental payments on dry runs and not a part of the payment methodology as described and outlined below. This was the one area outstanding between DHS and CMS last time we had an update.

Update as provided by DHS:

The Centers for Medicaid and Medicaid Services (CMS) approved the Medicaid State Plan Amendment (SPA) last Friday. CMS still needs to review and approve the 42 CFR 438.6(c) pre-print document before the State can implement the payment in Medicaid managed care.

We also wanted to bring to your attention a change that CMS required during the SPA approval process that impacts 'dry runs'. As you know, dry runs occur when there is no transportation of the patient to a medical facility. CMS has clarified that dry runs that provide no services or transport are considered a non-allowable cost on the cost report, however, the dry run transports still need to be reported as a transportation unit on the cost report for calculation of the average cost per transport. Additionally, CMS state that dry runs where services are provided, but there is no transport might be covered under a different part of the Medicaid State Plan and not part of the GEMT prospective payment methodology. This results in the final allowable cost only being associated with transports. We are currently reviewing the Medicaid State Plan to see if there is authority to pay dry runs where services are provided separate from the GEMT prospective payment methodology.

As far as an implementation date, we will be able to determine that after approval of the 42 CFR 438.6(c) pre-print and communicate it to you as soon as possible.
