Bureau of Emergency & Trauma Services Report – IDPH Rebecca Curtiss, Bureau Chief BETS

- Transitioned Medical Director on July 1, 2021 from Dr. Stilley to Dr. Ahmed.
- 1200 AED's in Law Enforcement Vehicles across the state. Now have a retired trooper overseeing this program.
- Brad Van De Lune is now Compliance Officer for the Bureau of EMS. Lots of applications for the EMS Coordinator position he vacated.
- COVID ongoing response with the Bureau. In the southern counties. Vaccinations are not real high down there. Working on that. Delta Variant is in the works now.
- Additional COVID funding 15 million for 40 New COVID Staff for a 2-year project period. They will work at the Service Level at the Coalitions. Multiple EMS Response and Recovery Person to work on improvement planning within each Coalition. Open to suggestions on the job description for these new jobs, or objectives or outcomes.
- Chapter 147A Changes allowing EMS programs to do training. Updated 139 that includes EMS Programs. It will not be noticed until September so it will be six months from that until it gets to the Rules Committee. Will be working with EMSAC on understanding the application process is to be able to do this.
