IEMSA 2017 Talking Points

Building Partnerships for a Better Iowa

Township Taxation for Fire/EMS - Iowa Code chapter 359 requires townships to provide fire protection, cemetery maintenance and fence line disputes. Those might have been great ideas in the 19th and 20th centuries but times have changed. Townships should be required to provide or help fund emergency medical service within their jurisdictions. IEMSA urges the Legislature to review how local governments provide public safety protection in the hopes of closing the gaps in coverage that predominately affect rural lowa. IEMSA believes that tax dollars need to be redirected to meet the current public safety needs of rural lowa.

Behavioral Health Transport

lowa's system of helping patients with behavioral health issues in times of crisis is broken. IEMSA believes that the limited supply of available behavioral health beds and increasing demand for behavioral health services adversely affects patients and their families. When we transport these patients - often times at long distances from their homes - we are unavailable to protect our local communities in their times of need. IEMSA urges the Legislature to help fix this problem by reviewing the system to make it more efficient for patients, providers and the communities that fund EMS for their taxpayers.

Volunteer Income Tax Credit

Volunteer EMS personnel can claim a \$100 credit against their personal income taxes due. IEMSA believes that this is an important tool in recruiting and retaining volunteers to help protect their communities, and it should be increased to a more generous level. Incentives for EMS Education - In addition to facing shortages in qualified applicants for current positions, lowa's EMS programs will soon need to replace those who have been in the profession for 30 or more years. IEMSA urges the Legislature to review the current requirements to start and continue a career in EMS, and create incentives (such as tuition tax credits or a match program) that will allow our programs to replenish the supply of qualified EMS professionals for the next generation.

Increase Medicaid Reimbursement for Mileage -

lowa's Medicaid mileage reimbursement rate for ambulance service is significantly lower than most all surrounding states. IEMSA urges the state to increase the Medicaid mileage reimbursement rate from \$2.61/mile to the Medicare rate (\$7.24/mile for urban, \$7.34/mile for rural) or a comparable private insurance rate.

Motioned to approve Talking Points – Katy Hill 1st, Mark Sachen 2nd – Motion Carries. Approved.

ByLaws Changes –Mark McCulloch—Reviewed and discussed bylaw changes that would change who would be eligible to be a board member. A lengthy discussion about how to expand membership occurred. Also to consider including Pre-Hospital Disaster Preparedness people to be members of IEMSA. Edits were made to language as it was discussed and agreed on by the board members present at the meeting and will be submitted for approval at the Annual Meeting, November 10, 2016--Motioned for approval at the Annual Meeting Nov 10, 2016.

EMSAC – L. Frederiksen – Meeting last week –went through some protocol changes, QASP meeting—Amy Gehrke attended her first meeting.

Epi—Rebecca Curtis, EMS Bureau Chief is working on putting the language in place – regarding the cost.

New Drug –Heroin is and car Fentanyl are hitting the streets. Be aware of what is out there. There are lots of pricing updates on medications; concerns about potential price gouging for Narcan is being investigated by the Iowa Attorney General's office

Mobile Integrated Healthcare—need a multi-disciplinary approach—so it is looking like we'll work on this done through EMSAC. Rob Marsh and Sara Solt, Katy Hill, John Jorgensen, LaDonna Crilly all attended the meeting. LaDonna Crilly and John Jorgensen—are working on gathering some data—about 10% of our calls were repeat calls.
