 - EMS Memorial Ceremony– Held the EMS Memorial Ceremony adding names to the Monument.
 - EMS Week Kickoff BBQ IEMSA hosted the 2nd Annual BBQ following the EMS Memorial Ceremony.
 - Lobbyist. Continue to contract two Lobbyist. Cal Hutman and Mike Triplett.
 - Special Projects included welcoming IEMSA's new Medical Director Darrell Forslund, MD, negotiated the Group Purchasing Contracts including office supplies, sent representation

to the first ever National meeting of State EMS Associations, sponsored two individuals at the Star of Life Conference..
