Call To Order - Mark Sachen, President at 1:02pm

<u>Welcome/Roll Call/Proxies/Determination of Quorum/Conflict of Interest</u>-- Lisa Arndt, IEMSA Office Manager – Roll Call, Quorum met. See end of minutes for attendance.

<u>Motion to Approval of Agenda –</u> Mark Sachen, President **Mot Lobbyist Report**–Eric Goranson

- Met with Rep. Bobby Kaufmann he is going to talk to our EMS bill sponsor, Brian Best, and see about putting a few different funding pieces together this year. He is interested in increasing an EMS fund with IDPH, is interested in our bill, and thought a training program is a good idea. We may not know exactly what we have by way of any commitments for a while.
- Met with Jane Bloomingdale Length of Service Award allows municipalities to financially reward volunteers for their service. She's been talking to John Pedersen with volunteer firefighters about it and I told her we'd be supportive of something like that.
- We spoke about county taxation issue and I made it clear that money was half the issue and that this bill would help with that be we need to find ways to address the labor shortage alongside that issue and we have fewer solutions for that.
- We spoke about a training reimbursement fund of some type. We agreed to follow up.
- I have mentioned our main issue to 6 or 7 legislators over the last few weeks. No one bats an eye at the ideas. The big issue is whether we can get in the budget.
- I'm going to try to set up a legislative leadership meeting or two before session starts.
- I know members and EMS personnel in general are asking what the plan is. Only so much we can share with everyone except that we are regularly meeting with legislators, there is a real desire to do something this year, but nothing is ever guaranteed, and that we are pushing the county taxation bill.
- I have a phone call scheduled with IHA lobbyist later this afternoon.

Bureau of Emergency & Trauma Services Report – IDPH Rebecca Curtiss, Bureau Chief BETS

- January 8, 2020 Chapter 131, 132 & 139 will go in front of the Board of Health. Earliest day they will be approved is early May.
- January 8, 2020 -- QASP will be a joint meeting in the afternoon.
- AED for Law Enforcement Grant Application-Helmsley Foundation for an AED for every law enforcement vehicle in the state
- New EMS Coordinator Michelle Short is replaced by Gary Merrill who started December 13
- ImageTrend Contract Changes—Legislators concerned about collection by IDPH of patient data. We've made some amendments to the contract with ImageTrend that mean the data will be destroyed 7-years after the collection.
- EMS Compact in Chapter 131 the changes are in there for this. Background checks are the biggest changes in Chapter 131.
 Background Checks will need to be mailed off and wait for return. IDPH will share Yes or No only on NEW Certifications. Other details will not be shared.
- Registry Sharing is the last piece to flush out.
- Chapter 139 Sen. Chapman has some ideas about the training changes. She will share with Eric Goranson.
